

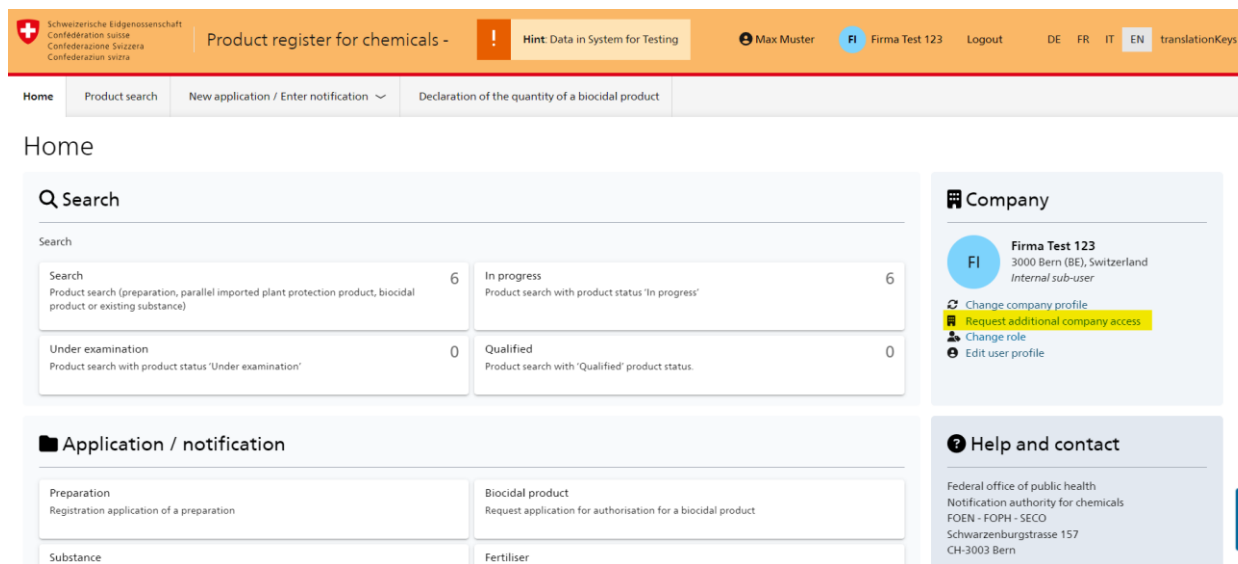
Instructions: Create an additional access request for another company

Preconditions:

- The CH-Login/AGOV has already been created. Info: [How to create a AGOV \(user account\)](#)
- The user logged in to RPC with his own account.
- You already have at least one existing corporate access

1 Request further access to the company (company profile),

- If you already have corporate access, you can request further access at any time.
- To do so, go to the start page.
 - Click on the link **Request additional company access** (in yellow) on the right-hand side of the box with the company data.

- Search for the desired company via UID/VAT number, CID number (company number within RPC), or company name.
- Select the correct company from the search results (click on the desired company) and then click **Next**.
- If the search results do not yield the correct result, manually create a new company (see Step 3b)

2. Step: Define the user type

4 **4a** **Rule:** Every company must have at least one main user

→ If it is a newly created or newly registered company, the first user type must always be a main user.

4b If a main user already exists for the selected company, the desired user type can be chosen between an additional main user, sub-user internal, or sub-user external.
